SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

General notes

In case of accident or if you feel unwell, seek medical advice immediately (show the label where possible). Never give anything by mouth to an unconscious person. Place patient in recovery position and ensure airway patency.

Following inhalation

Remove patient to fresh air - move out of dangerous area. Obtain professional medical help! In case of unconsciousness bring patient into stable side position and seek medical attention.

4.2 Most important symptoms and effects, both acute and delayed

Following inhalation

Vapours may cause drowsiness and dizziness. Symptoms include: headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, unconsciousness. Excessive exposure to spray mist, fog, or vapours may cause respiratory irritation.

Following skin contact

Causes corrosions, heavy burns. Skin burns: Signs/symptoms may include localised redness, swelling, itching, dryness, blistering.

Following eye contact

Corrosive effect. Risk of serious damage to eyes. Redness, pain, burning sensation, tearing, can cause permanent damage to the eyes.

Following ingestion

Harmful to health. May cause nausea/vomiting. If ingested, causes severe burns of the mouth and throat, as well as

perforation of the esophagus and stomach. Aspiration into the lungs causes coughing, shortness of breath and may lead to chemical pneumonia. May be fatal if swallowed and enters airways.
